**RESOLUTION REAFFIRMING ELON UNIVERSITY STUDENT GOVERNMENT  
ASSOCIATION'S STANCE ON NORTH CAROLINA HOUSE BILL 2:**

**WHEREAS:** On March 23rd, 2016 the North Carolina General Assembly passed House Bill 2: The Public Facilities Privacy & Security Act, a highly discriminatory act that targeted LGBTQIA+ citizens and visitors of North Carolina, and;

**WHEREAS:** Elon University's Student Government Association passed resolution S.R.16-1, reaffirming the University's institutional commitment for an inclusive campus community and providing equitable treatment for not only the students on Elon's campus but to all of the citizens and visitors of North Carolina, and;

**WHEREAS:** House Bill 2: The Public Facilities Privacy & Security Act was repealed on December 1, 2020 via a sunset provision within the North Carolina General Assembly, and;

**WHEREAS:** LGBTQIA+ individuals deserve to feel respected and included in the spaces that they are in, and;

**WHEREAS:** Eight (8) local municipalities in the State of North Carolina have passed anti-discrimination legislation, condemning discriminatory acts within their respective towns, therefore;


**BE IT RESOLVED BY THE STUDENT GOVERNMENT OF ELON UNIVERSITY  
THAT:**


**ARTICLE I:** Elon University Student Government Association reaffirms the statement made in S.R 16-1 and condemns other state and local laws within the United States that discriminate against LGBTQIA+ individuals.

**ARTICLE II:** Elon University Student Government Association pledges to uphold the University's efforts to work towards a more inclusive community, both on campus and in the surrounding community.

**ARTICLE III:** Elon University Student Government Association supports any attempt by the Town of Elon Board of Alderman to provide a more inclusive environment for the LGBTQIA+ community in the Town of Elon.

**ARTICLE IV:** The Speaker of the Senate shall be responsible for sending copies of both this resolution and a copy of S.R. 16-1 to each Senior Staff member at Elon University, the Executive Director of Elon News Network, each of the Town of Elon Board of Alderman, the Town of Elon Mayor, and the Town of Elon Town Manager.




