



## PARKING RULES & REGULATIONS AT A GLANCE

WELCOME TO ELON! Any Elon University student or employee may have a vehicle on campus provided it is properly permitted and legally parked. It is the responsibility of the permit holder to be aware of and comply with parking rules and regulations. **Permitted Parking:** There are numerous parking lots on campus. The type of permit you have determines where you may park. Besides the permit designated lots, all Elon University students (**except first year residential students – FY permits**), staff, and faculty with a valid permit may park in the following lots at any time unless restricted due to a special event:

**Visitors:** All visitors to campus must have a visitor parking permit, which is complementary and may be obtained through the Elon Campus Safety Parking Office. Visitors with a valid permit may park in any lot, except the Inman Admissions lot. If going on an Admissions tour, please contact Admissions for parking directions.

**Student Athletes:** Any student athlete, with a valid parking permit, may park in the northernmost part of Hunt A (the lot immediately to the north of the north entrance to the Schar Center), **ONLY when participating in team organized meetings or practices**. Violation of this rule may result in the revocation of this parking privilege.

### IMPORTANT

- All North Carolina State laws apply on campus
- Towing is enforced! Any person parking in an area other than the area indicated on their permit will be in violation and may be ticketed and/or towed at their expense
- Parking Rules and Regulations will be enforced year-round, including breaks, holidays, summer, and special days (i.e., SURF Day)

## Rules and Regulations

The letters on your parking permit indicate your assigned parking areas. Any vehicle parking in any other space is in violation of campus parking regulations.

Parking in restricted/reserved areas and no parking zones, without a proper permit could result in a fine and/or tow. The University reserves the right to change motor vehicle policies when necessary.

Finally, the University does not assume responsibility for any person's motor vehicle when it is parked on campus. Parking is a privilege which can be revoked for rule violations.

Vehicles may only be operated on paved streets and shall be parked appropriately in designated lots. Parking or driving on the grass or Tram Path is prohibited.

### First Year Residential students (FY permits) -

First Year Residential students (FY permits) must remain in their designated lots 24 hours per day, seven days per week, unless requested to move due to a special event.

### Fire Lanes – MAY OR MAY NOT BE MARKED -

Vehicles parked along a curb (unless clearly marked as permissible parking as in a parking lot), even if the curb is not painted yellow, or parked in the travel portion of the street or parking lot will be considered, "**Parked in a Fire Lane**" and may be ticketed and/or towed.

### Street Parking

Faculty/Staff may park on East Lebanon Avenue (north of railroad tracks).

Parking on the streets in the Town of Elon is under the town's jurisdiction. Anyone using such space should understand and obey the parking regulations of the Town of Elon.

**Disabled Vehicles** must be reported to Campus Safety & Police, 336-278-5555. ***\*Notes on vehicles are not acceptable\****

## Registration

Any student who wishes to park a motor vehicle on property owned or leased by the University **must** purchase a parking permit. This includes students with state issued handicap placards or plates. These students may park in any handicap accessible spot on campus regardless of permit type.

### Registration Fees

The parking permit fee for 2025/2026 is \$225.

Exception: Student Global Neighborhood fee is \$100.

(These students are required to move their vehicles on football game days and during select basketball game days.)

\*Permits purchased January 1 to May 1, are reduced to half price, except for Global Neighborhood\*

### Bicycles

***All bicycles must be registered*** with the Campus Police (at no cost). If you have a bicycle or motorized bicycle, it can **ONLY** be parked in areas designated for bicycles (bicycle racks). Bicycles not registered or found in any area not designated for bicycles including, but not limited to stairwells, railings, brick colonnades, and gazebos, will be confiscated.

### Visitors on Campus

If you have a visitor on campus, you will need to get a complimentary visitor pass at the parking office and advise them of parking rules, including game day parking.

### **HN – Historic Neighborhood \$225**

Historic Neighborhood Residents (Academic Village, Carolina, Hook, Brannock, Barney, Sloan, West, Virginia and Smith, East Area Neighborhood)

- Historic Lot

### **LEV – Low Emission Vehicle**

- LEV vehicles may only park in the lots they are permitted for. LEV permits must be obtained from the Elon Campus Safety Parking Office

### **LS – Law School FREE**

Law School Students

- **Elon University School of Law Greensboro, N.C.** Faculty/Staff permit will be issued by The School of Law to the Bellmeade parking garage on Green St.
- Law School students may obtain a Law School (LS) permit and park at the university parking lot located at Church Street and Friendly Ave., Greensboro
- Permits will be issued by the Director of Academic and Administrative Services.

### **MP – Station at Mill Point \$225**

- Mill Point

### **OK – Oaks, Park Place \$225**

Oaks and Park Place Residents

- Oaks Lot (non-faculty/staff/visitors spots only)
- Park Place Lot (designated spots only)

### **20 Minute Parking**

- Spaces are for registered vehicles ONLY with a valid permit displayed

## PERMIT PLACEMENT

### Students

Parking permits must be **clearly visible and affixed** to the right front section of the vehicle’s front windshield.

### Faculty/Staff Permits

Hang from rear-view mirror. Do not place on dash.

### Motor Bikes and Motorcycles

Place the permit on the rear fender.

### Handicap/Accessible Parking

To legally park in a Handicap/Accessible space on campus, a vehicle must display an Elon Parking Permit and one of the following:

- Handicap/accessible license plate
- Disabled veteran license plate
- Placard issued by the Department of Motor Vehicles **to person using the handicap placard.**

Students in need of a temporary handicap/accessible parking permit should contact the Office of Disability Resources (336-278-6568).

Employees in need of a temporary handicap/accessible parking permit should contact the Office of Human Resources (336-278-5560).

## PLEASE NOTE

- The University cannot always guarantee a convenient parking place. Parking is available in overflow locations as needed. Lack of convenient space is not a valid excuse for violation of the University’s parking policy.
- Faculty/Staff parking lots are CLOSED to students Monday through Friday from 6:00 a.m. to 6 p.m. and is enforced year-round. Any vehicles in violation may be ticketed and towed.
- Note: Parking in the Inman Admissions lot is prohibited for students, staff, and faculty seven days a week between the hours of 6:00 AM and 6:00 PM.
- Students are not considered visitors and should not park in the visitor spaces.
- Parking at The Inn at Elon is for guests only, 24/7. Students, faculty, and staff are not permitted to park there unless they are a guest visiting The Inn or The Mark.

## VIOLATIONS, FINES, AND TOWING

*Students with unpaid traffic tickets will not be permitted to participate in graduation exercises or obtain transcripts.*

### Tow-Away Protocol

Five or more parking violations during the academic year may result in a vehicle being towed.

### Appeals Process

If you wish to appeal a parking fine, you must do so within seven (7) days of the date of the ticket. Appeal Forms should be filled out online: <https://elon.edu/parking/tickets/>

### Tow-Away Zones

**Any vehicle parked in a tow-away zone may be towed immediately!**

Tow-away zones include any traveled portion of a street and/or parking lot, fire lanes, spaces restricted/reserved for live-in staff, handicap/accessible spaces, grass or sidewalk, maintenance spaces, tram path, visitor's lot, faculty/staff lots, 20-minute spaces, or any other area deemed a safety hazard.

**All unpermitted vehicles are subject to be towed.** If a vehicle on campus is towed, the owner is responsible for paying the fine and tow fee prior to picking up the vehicle. If the tow truck has been dispatched but has not yet arrived on scene, the owner must still pay the towing fee.

<b>Towing Fee</b>	<b>\$100</b>
<b>Traffic Violation Fine</b>	<b>\$50 - \$200</b>

The total fine/fee to release the vehicle will be **\$150 - \$300** depending on the traffic violation.
