#### **general textbook information:**

The textbooks listed below are required for the Fall trimester unless marked as “recommended.” Textbooks are available from a variety sources, including the Barnes & Noble bookstore at Elon University and popular websites. Students may purchase new or used books, or rent books. There are web sites available for comparing book prices, such as [www.bookscouter.com](http://www.bookscouter.com).

Some Elon Law faculty members allow the use of electronic books (eBooks), while others do not. Here are some points to consider:

- It may be challenging to use a laptop computer to take notes in class, while also trying to reference an eBook on the same device.
- The software for some eBooks may be “clunky,” which can lead to lag time and other issues.
- Some eBooks are not paginated in the same way as the paper versions. Professors may assign readings according to the paper version and expect students to figure out the corresponding eBook pages.

Students should direct questions about the textbook(s) for a specific course to their course professor. Students who cannot access a reading assignment to prepare for their first class meeting should inform their professor promptly.
