REGISTRATION:

Summer 2022 registration opens March 1st at 12:45 p.m.

Online registration for summer courses for all students ends on **May 22nd**.

There are no refunds beyond these dates.

A student who takes a Summer Session course at the Law School and is notified during the summer that they have been academically dismissed may be allowed to complete the course for credit or may withdraw from the course. If an academically dismissed student withdraws from a Summer Session course after the drop-add period is over, no tuition refund is available. If a student is taking a summer course with another school, including a study abroad course, the dismissal's effect on eligibility or academic credit is up to that school.

ABA RULE ON ONLINE COURSES:

A law school may grant a student up to one-third of the credit hours required for the J.D. degree for distance education courses. A law school may grant up to 10 of those credits during the first one-third of a student's program of legal education. The ABA granted the Law School a variance from this rule for the 2020-21 academic year, so online courses from Fall 2020, and Winter, Spring, and Summer 2021 do not count toward this total. Online accompanying courses taken during Residency do count in the total of online courses. Also, courses taken in Fall 2022 likely will count toward the total. Any credits taken in online courses over the 28 online credit hours allowed will not count toward graduation. It is each student's obligation to ensure they do not exceed the allowed amount for online courses taken.

TUITION:

Tuition for Summer Session is charged per credit hour. Tuition is \$1,500 per credit hour. Students registered for the Law School Summer Sessions will receive a billing statement from the University. Payment in full or payment arrangements (e.g., confirmed financial aid) must be made by the payment due date on the billing statement to avoid the cancellation of courses.

FINANCIAL AID:

Students enrolled for at least two credit hours in either Summer Session are eligible to apply for financial aid for that session. LAW693A Advocacy Fellows Externship Staff 3 credits

The Advocacy Fellows Externship provides practical legal experience under the supervision of an attorney in an advocacy setting. Examples of advocacy settings include litigation practices (e.g., district attorney, attorney general, public defender, legal aid, or another law office that engages in courtroom advocacy, as well as judicial offices), or offices engaging in policy or social advocacy (e.g., non-profit organizations, government agencies, or other entities). The course requires a minimum of 135 hours of work. Registration is limited to Advocacy Fellows in compliance with all Fellows criteria. See Advocacy Externships FAQs.

Students may not receive any compensation for work in the Externship course. Professional Responsibility is a prerequisite if the placement requires certification under the North Carolina State Bar Limited Practice Certificate Program. This course may span both Summer Sessions I and II.

LAW692A Business Fellows Externship Staff 3 credits

The Business Fellows Externship course provides practical legal experience under the supervision of an attorney or judge focusing in the area of business law. The course requires a minimum of 135 hours of work. Registration is limited to Business Fellows. **Students may not receive any compensation for work in the Externship course. Professional Responsibility is a prerequisite if the placement requires certification under the North Carolina State Bar Limited Practice Certificate Program. This course may span both Summer Sessions I and II.**

LAW671A Commercial Law: Secured Transactions Dean Woodlief 3 credits

This course is a study of the law of secured transactions, focusing on Article 9 of the Uniform Commercial Code. Each week, students are assigned textbook chapters to read and problems to work. Dean Woodlief posts recorded lectures and review problems online each week. **This course is completely online, so students can listen to weekly lectures, do the course reading, and work on weekly problems on their own schedule, to complete by the weekly deadline.** There are online chat forums and office hours each week, for students to connect with Dean Woodlief and ask any questions they may have about the material for the week. Dean

Woodlief is available other times during the week by appointment. Regular, weekly participation is an important part of the learning process in this course and is also a proxy for attendance. A component of the grade will measure by participation (e.g., logging in and watching lectures, working textbook problems, answering review questions online, and submitting assignments). Students' participation will be monitored through Moodle and through students' submissions. Lack of consistent and timely participation in the course will result in a reduced grade in the course (as detailed in the syllabus). There will be at least one quiz and likely two, as well as a final exam. The quizzes will be submitted through Moodle, and the final exam will be through ExamSoft, so students do not have to be at the law school for the quizzes and exams.

LAW757A First Amendment: Speech Professor Gaylord 2 credits

This course surveys the Free Speech clause of the First Amendment and considers both the theory underlying the clause and judicial interpretations of the extent of its protections. Potential topics include hate speech, political speech, freedom of association, indecency and obscenity, tort law and the First Amendment, access to the media, commercial speech, and copyright. The course pays particular attention to the application of free speech rules, doctrines, and values to emerging technologies. **This course is completely online, so students can listen to weekly lectures, do the course reading, and work on weekly problems on their own schedule, to complete by the weekly deadline.**

LAW690A General Externship**Staff****3 credits**

The General Externship course provides practical legal experience under the supervision of attorneys and judges. Students earn 3 credits for 135 hours or 4 credits for 180 hours of qualifying work, at a non-profit, government, judicial, or in-house counsel office. Qualifying work is substantial lawyering experience reasonably similar to the experience of a lawyer advising or representing a client or engaging in other lawyering tasks under approved direct attorney or judicial supervision. In addition to the minimum hours of supervised work, the General Externship requires students to participate in sessions with a faculty advisor and with other externs (in person, by phone, or via Zoom) and submit reflective written work and time records. Students are eligible for the General Externship course after completing three trimesters at the law school. To register for the course, students must have their placements approved by the Director of Residencies. Applications stating all requirements are at:

LAW689A Leadership Fellows Externship**Staff****3 credits**

The Leadership Fellows Externship provides practical legal experience under the supervision of an attorney or judge who is either 1) working full-time in public service or 2) is in private practice but plays a leadership role in the Bar, in *pro bono* service, or in the community. Qualifying placements include all levels of attorney general, prosecutorial, and public defender offices; state and federal governmental agencies such as the Social Security Administration, EEOC, and EPA; law offices of past and present officeholders in local and state bar associations; and law offices of members of the N.C. Pro Bono Society. The course requires a minimum of 135 hours of work. Students are also required to participate in group and individual meetings with a faculty advisor and to engage in reflective discussions. ***Students may not receive any compensation for work in the Externship course. Professional Responsibility is a prerequisite if the placement requires certification under the North Carolina State Bar Limited Practice Certificate Program.*** **This course may span both Summer Sessions I and II.**

It also examines the nature, establishment, management, and termination of inter vivos and testamentary trusts. **This course is completely online, which allows students to listen to weekly lectures, do the course reading, and work on weekly assignments on their own schedule, to submit by the weekly deadline).**

LAW720A Constitutional Law I

Professor Gaylord

2 credits

A study of the principles of American constitutional law, in particular the structure and design of the constitutional system and government of the United States, including the scope and separation of congressional, executive, and judicial powers. **This course is completely online [pending faculty approval], so students can, to listen to weekly lectures, do the course reading and work on weekly assignments on their own schedule, to complete by the weekly deadline).**

LAW732A Criminal Procedure**Professor Friedland****3 credits**

The major constitutional restraints upon the criminal justice process are the focus of this course. Particular attention is given to the provisions of the Fourth, Fifth, and Sixth Amendments to the United States Constitution, including arrest, search and seizure, interrogations and confessions, the exclusionary rule, and the right to defense counsel. Overall consideration is given to the impact of Fourteenth Amendment Due Process requirements throughout state and federal criminal justice systems. **This course is completely online, so students can listen to weekly lectures, do the course reading, and work on weekly assignments on their own schedule, to complete by the weekly deadline.**

LAW682A Professional Responsibility**Dean Woodlief****2 credits**

This course is a study of the professional obligations of attorneys imposed both by regulation and the noble traditions of the legal profession. The course uses hypothetical fact situations and problems likely faced by attorneys to reinforce the model rules and to develop a commitment to ethical decision-making in students. **This course is completely online, so students can listen to weekly lectures, do the course reading, and work on weekly assignments on their own schedule, to complete by the weekly deadline.** Each week, students read assigned textbook chapters and work problems. Dean Woodlief posts recorded weekly lectures and review problems online. There are online chat forums and office hours each week, so students can connect with Dean Woodlief and ask any questions they may have about the material for the week. He is available other times during the week by appointment. Regular, weekly participation is an important part of the learning process in this course and is also a proxy for attendance. A component of the grade measures participation (e.g., logging in and watching lectures, working textbook problems, answering review questions online, and submitting assignments). Students' participation is monitored through Moodle and students' submissions. Lack of consistent and timely participation in the course will result in a reduced grade in the course (as detailed in the syllabus). There will be at least one quiz and likely two, as well as a final exam. The quizzes will be submitted through Moodle, and the final exam will be through ExamSoft, so students do not have to be at the law school for the quizzes and exams. **Students who do not take Professional Responsibility during Summer Session II will be registered for the course in the Fall of their 2L year.**

LAW795A Remedies Dean Woodlief 3 Credits

This course examines the various remedies available to claimants in civil litigation. It will cover damages, including compensatory, punitive and statutory damages. Equitable remedies such as injunctions and accountings will also be covered. Restitutionary remedies will also be addressed. **This course is completely online, which allows students to listen to weekly lectures, do the course reading and work on weekly assignments on their own schedule (subject to submitting them by the weekly deadline).** The course format is as follows: Each week, students will be assigned chapters in the textbook to read and work problems. Dean Woodlief posts recorded lectures online each week, as well as review problems. The work is largely at your own pace during the week, though students will need to have listened to the lectures and completed the problems by the weekly deadline. There are online chat forums/office hours each week, so students can connect with Dean Woodlief and ask any questions they may have about the material for the week. Dean Woodlief is available other times during the week by appointment. Regular, weekly participation is an important part of the learning process in this course and is also a proxy for attendance. A component of the grade will be measured by participation (e.g., logging in and watching lectures, working textbook problems and answering review questions online and submitting assignments). Students' participation will be monitored through the Moodle online course system and through students' submissions. Lack of consistent and timely participation in the course will result in a reduced grade in the course (detailed in syllabus). There will be at least one quiz and likely two, as well as a final exam. The quizzes will be submitted through Moodle (Elon's online course site), and the final exam will be through ExamSoft, so students do not have to be at the law school for the quizzes and exams. More specific details will be available in the course syllabus and on the course Moodle site.
